

# Barrysparks and Crowscastle Masterplan Appropriate Assessment Determination

In accordance with the requirements of Section 42 (1) of the European Communities (Birds and Habitats) Regulations 2011 (S.I. No. 477 of 2011), a Screening for Appropriate Assessment of the Barrysparks and Crowscastle Masterplan was carried out by Fingal County Council which determined that an Appropriate Assessment (AA) was required.

This AA Concluding Statement has been informed by the content of the Masterplan documents which includes a Natura Impact Statement (NIS) that was prepared for the Masterplan, as required under Section 42 (9) of the European Communities (Birds and Habitats) Regulations 2011 (S.I. No. 477 of 2011). The NIS presents an assessment of the potential for the Masterplan to impact on Natura 2000 sites (hereafter referred to as European Sites) and furthermore assesses whether the Masterplan would impact on the integrity of any European Site(s).

The examination, analysis and evaluation of the Masterplan's opportunities, key objectives and key principles is set out in Section 4 of the NIS. The main body of the NIS presents a summary of the each stage of the assessment with detailed assessment and supporting information presented in the Appendices, as follows:

- Appendix A Table A1 Protective Policies and Objectives contained within the Fingal County Development Plan 2017-2023 – Measures to Protect sites of European and National Importance.
- Appendix B Table B1 Analysis of Likely Significant Effects on Conservation Objectives.

- South Dublin Bay and River Tolka Estuary SPA

Fingal County Council agrees with the findings presented therein and the conclusion reached with regards to identifying those European Sites at risk, in the absence of mitigation, as a result of implementing the Masterplan.

#### Potential for the Masterplan to affect European Sites within its zone of influence

The NIS identifies the risks to European Sites that may arise through implementing the Masterplan. This evaluation concluded that no adverse effects on European site integrity will arise from the implementation of the Masterplan acting in-combination with any plans or projects located within the ZoI of the Masterplan.

Fingal County Council considers that the scope of this evaluation has fully examined the potential for in-combination effects between other plans and projects and the Masterplan and agree with the conclusion reached.


