Introduction

We welcome this strategy from the Joint Policing Committee (JPC) which sets out how we will work in partnership for the next three years. Fingal Co Council and An Garda Síochána share a joint aim to partner with other statutory agencies and with local residents to keep existing and new communities in Fingal safe, protect those more at risk, and provide a high standard of service to local residents and visitors to the county. Devising this three-year strategy has involved input from each of our JPC members¹; we acknowledge their efforts to address the many challenges raised by residents in our consultation process.

Preliminary results from the 2022 census show that Fingal is one of the fastest growing regions in Ireland with the highest number of young people in the Dublin region and a high proportion of non-Irish nationals. It is incumbent on us to ensure that each person in every community has the right to be safe and to feel safe, so that they can thrive and flourish. We want everybody to be able to participate safely and contribute to the best of their ability to civic and social life in the county.

The three-year JPC strategy focuses on the specific needs of our communities and residents, with special regard for those who are more vulnerable. A shared approach to problem solving can ensure that situations do not develop to the point where they impact on the safety, or a feeling of safety in the community at large. This means that we work with each other and the community to ensure there is better coordination between services such as educational and youth work in Fingal, local health and mental health services, drug prevention, housing and the built environment, and actions taken to combat substance misuse, domestic abuse, youth crime, anti-social behaviour, and hate crime.

The strategy will guide the work of the JPC over the next three years. We have outlined specific and measurable objectives with defined timescales for delivery. They will be monitored on a quarterly basis by the JPC. Through the collaborative actions set out in this strategy, we will support and add value to the existing work of our members. Working in partnership with them and with our communities, we will ensure that Fingal retains its strong sense of place, identity and wellbeing, where visitors and residents can enjoy what the county has to offer in the safest possible way.

The Context

Joint Police Committee: Its purpose

The Joint Policing Committee (JPC) is a forum, where the local authority and senior Garda officers responsible for local policing, together with Oireachtas members and community interests consult, discuss and make recommendations on matters affecting the policing of the area.

It is a partnership where members operate with the minimum of formality to identify, raise awareness of and find solutions for issues impacting on, or causing concerns for the local community. In this way, it contributes to the improved safety and quality of life of the community.

The JPC is not a substitute for either regular day-to-day contact or consultation at ground level, which is a feature of ordinary policing. It should not detract from the maintenance and development of suitable liaison between local authority, Garda representatives and local communities.

The Benefits

The JPC plans strategically to address individual priorities in relation to community safety and wellbeing in local areas. It entails a 'multisectoral approach, strong inter-agency collaboration and proactive dialogue with the community'². Decisions made by any of the interests represented on the JPC are better informed as a result of the discussion of local needs and circumstances.

The JPC acts as a mutually supportive mechanism through which the local authority can have a role in conveying information and views to Garda Divisional and District officers to assist them in the formulation and operation of their annual policing plans.

Equally, Garda Divisional and District officers can convey information and views to the local authority to assist it in carrying out its duties, functions and activities. This means that Fingal Co Council works in partnership with An Garda Síochana and the community to address certain areas of policing including but not limited to:

- Anti-social behaviour
- Drinking in public places
- Safer neighbourhoods estate management
 (including tenancy enforcement and public lighting)
- Road safety and traffic management
- Planning of major events attracting large crowds
- Outdoor dining and casual trading
- Community-based crime prevention initiatives etc.

Fingal: A Profile³

POPULATION

The 2022 Census recorded a population of 330,506, in increase from 2016 of 11.6%, or just over 34,000 people. The County hence accounts for 6.4% of Ireland's population with only Dublin City and Cork City and County accounting for higher proportions. Fingal's population is expected to continue to grow with the Fingal Development Plan 2023 – 2029 forecasting that the county's population will increase by approximately 73,000 people by 2021, an increase of 22.1% versus 2022.

AGE

26.7% of the Fingal population was under 18 years old in 2022, while 134,264 (40.6%) were under 30. 16% were between 50 & 64 while 11.05% of the population were aged 65 and over. The proportion of under 30's in Fingal was higher than at the national level, where 38% of the population was under 30. Fingal had the youngest average age in 2022 at 36.2 years with some 63% of the population below the age of 44, compared to 58.3% nationally.

HOUSEHOLDS

According to the 2022 Census, the number of private households in Fingal reached 107,846, an increase of 11.4% from 2016. Growth was higher than the national average rate over the period (+8.2%). Average household size in Fingal in 2022 was 3.02 persons.

Glossary

ASBO	Antisocial behaviour orders can be used to stop anyone aged 10 or over from harassing, causing alarm or distress to other people who aren't in the same household. An order can be issued for at least two years and lists what they must stop doing.

CYPSC	Children and Young People's Services Committees – Interagency working to improve the lives of children, young people and families in Ireland.
DATFS	Drugs and Alcohol Task Forces research, develop and implement a coordinated, regionally appropriate response to substance misuse.
